Call to Order:

Approval of Minutes:

New Business:

1. It is necessary for the supervisors to find a replacement for Joe Koons to the Municipal Authority since his resignation dated 2/19/09. Mike reported that it would be great if a resident would step forward that has a background in sewage

- planning or construction but we would be most appreciative of any of our residents taking on this very important position.
2. There was discussion regarding 2009 paving projects and it was decided that we should delay any extensive paving for 2009. Gary reported that dust oil would be placed on Welliver Road and Klein Road should have tar and chip. There should probably be an overlay placed on some of Indian Run Road. Judy reported that the Montour County Council of Government asked the townships if they wished to go through the COG for their paving, they would like to have the information at their next meeting, March 18. Judy will also put the bidding information out for the stone, oil and diesel.
 3. Judy reported that the Hite Company gave to the township a rebate of \$380 because of the delay in delivery of the bulbs.
 4. DEP granted the armory 14 EDU's.
 5. Gary will take care of moving the "school bus ahead" sign on Rt 54.
