### Call to Order:

Fire Department-Per Matt Gum, Fire Chief, just returning to quarters from active call, there were 12 incidents during the month of April.

Planning Commission-Letter from planning commission for application submitted for conditional use of property off Sugar Camp Road recommending supervisors include the proposed conditions for use as part of any approval of the conditional use application: (1) right of way agreement and access road that meets current ordinances, (2) easements of power lines.

Municipal Authority- Larry reports, take over continues. Act 94 accepted. Act 537 deficienciesplanning a rebuild of Indian Run Road pump station, credits completed, 25 accts. in arrears, Supervisors will be paid in full.

- (6) Road Foreman/Equipment Report- Gary reports, F-550 needs fuel tank, road crew will evaluate to consider repair or replacement. Many parts are becoming obsolete.

<u>Old Business:</u> Motion was made by Larry, 2nd by Gary, to sign a letter of support for the pickleball group to obtain grant funding. Motion carried unanimously.

Solicitor will prepare letter, supervisors will have it signed by next meeting, Secretary will email signed letter to the pickleball group.

Rob Anderson w/Wentz Surveying ask Supervisors to take action on Puderbaugh plans-sign a non-building waiver (no buildings, no sewage/changes or proposals, land will always stay in current state whether sold or kept.)

Motion made by Gary, 2<sup>nd</sup> by Larry to approve Puderbaugh's subdivision, the township will need two copies. Motion carried unanimously.

### **New Business:**

- Sugar Camp Road Solar Project discussion held w/engineer, attorney, and project planners requesting a conditional use hearing. Citizens and nearby land/homeowners expressed concerns about how water runoff from solar panels would affect ground water, and what was the life expectancy of the panels. Planning Commission recommendations: (1) easement of powerlines, (2) 25 yr. life expectancy/panels replace suitable upgrade or remove fixtures and farm would be restored to its original state. Gary and Larry meet in an executive session concluding recommendations that the plan map be updated, decommissioning clause, and review with engineer and FAA. Project planners will get needed information to the secretary.
- Supervisors will reach out to Robert Fugate, SEO, for recommendations regarding again runoff concerns at 70 Garman Road.
- The treasurer requested permission to have PPL monthly bills automatically withdrawn from account. Supervisors granted request.
- Bid packets opened as advertised.

Motion made by Gary, 2<sup>nd</sup> by Larry that Midland be awarded scratch and seal bid, as lowest responsible bidder and motion carried unanimously.

Motion made by Gary, 2<sup>nd</sup> by Larry that HRI be awarded paving bid, as lowest responsible bidder and motion carried unanimously.

<u>Approval of Bills:</u> Motion made by Larry 2<sup>nd</sup> by Gary to ratify the payment of Bills and motion carried unanimously.
